RESOLUTION NO. 50

A RESOLUTION approving and confirming the assessments and assessment roll for Local Improvement District No. 5 in Silver Lake Water District, Snohomish County, Washington, in the sum of \$ 6341.42, for the improvement of the property described in Section 1 of this Resolution, by the construction and installation of a distribution system of water mains, and doing all necessary work in connection therewith necessary to conduct water from the Silver Lake Water District General Supply System to the property within the boundaries described in Section 1, in accordance with Resolution No. 45 of said Water District, passed on the 8th day of November, 1954, levying an assessment on account thereof against the several tracts, lots and parcels of land as shown on said roll, and no person appearing to object to said assessment roll and no written protests having been filed, NOW THEREFORE:

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER DISTRICT, SNOHOMISH COUNTY, WASHINGTON:

Section 1: That the assessments and the assessment roll, as the same now stands, of Local Improvement District No. 5 for the improvement of the following described property in said Water District, to-wit:

Beginning at the center of Section 17, Township 28 N. R. 5 E. W. M.; thence Easterly along the center line of said Section 17 to a point 330' more or less East of the center of the Section; thence South 330' more or less; thence East 330' more or less to the East line of the $W\frac{1}{2}$ $W\frac{1}{2}$ of $SE\frac{1}{4}$ Section 17; thence Southerly along said East line to the Southeast corner of the $NE\frac{1}{4}$ $NW\frac{1}{4}$ $SW\frac{1}{4}$ $SE\frac{1}{4}$ Section 17; thence West 330' more or less; thence Southerly to a point approximately 330' East of the $S\frac{1}{4}$ corner of Section 17; thence West along South line of said Section 17 to the West line of the $E\frac{1}{2}$ $SE\frac{1}{4}$ $SE\frac{1}{4}$ $SW\frac{1}{4}$ of said Section 17; thence North along said West line to the Northwest corner of $E\frac{1}{2}$ $SE\frac{1}{4}$ $SE\frac{1}{4}$ $SW\frac{1}{4}$ of said Section 17; thence West to the Southwest corner of the $NE\frac{1}{4}$ $SE\frac{1}{4}$ $SW\frac{1}{4}$ of said Section 17; thence North to the Northwest corner thereof and continuing north along West line of

$E\frac{1}{2}$ $NE\frac{1}{4}$ $SW\frac{1}{4}$ of said Section 17 to the Northwest corner thereof; thence Easterly along center of said Section 17 to the center of said Section 17 and the point of beginning, situate in Snohomish County, Washington,

by the construction of and installation of a distribution system of Water mains and doing all necessary work in connection therewith necessary to conduct water from the Silver Lake Water District General Supply System to the property above described, in accordance with Resolution No. 45, passed on the 8th day of November, 1954, be and the same is hereby in all things approved and confirmed.

Section 2: That each of the lots, tracts and parcels of land or other property, shown on said roll is hereby declared to be specially benefited by said improvement in at least the amount charged against the same, and that the assessment appearing against the same is in proportion to the several assessments appearing upon said roll, and there is hereby levied an assessment against each lot, tract and parcel of land, or other property appearing upon said roll, the amount finally charged against the same.
