RESOLUTION NO. 597

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE SILVER LAKE WATER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, ESTABLISHING AN ADMINISTRATIVE FEE FOR PROCESSING CASH PERFORMANCE AND PLEDGE OF MONEY AGREEMENTS

WHEREAS, at the request of property developers the District recently enacted Resolution 578 establishing criteria to determine whether the District may arrange for contractual guarantees by developers that extension improvements will be completed and to provide letter notice to Snohomish County of such guarantees to allow developers to seek final subdivision approval and recording from Snohomish County prior to final completion of extension improvements by the developer; and

WHEREAS, staff has reported to the Board of Commissioners on the time and effort of staff to draft resolutions, process the necessary forms and other paper work to accommodate developers and to provide these services; and

WHEREAS, the staff estimated average cost of these District services is \$300.00.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Silver Lake Water District, Snohomish County, Washington as follows:

1. PURPOSE The District intends by this resolution to place the costs of staff response to requests for services pursuant to Resolution 578 as it now reads or as amended on developers making such requests and not on the general public. This fee is set to help ensure compensation to the District for all administrative costs and expenses associated with tasks specific to developer requests made in accordance with Resolution 578.


2. SERVICE FEES AND CHARGES The fee to administer and process the forms and other paper work and to offset additional field work by District crews for requests for


services made by developers in accordance with Resolution 578 as it now reads or as amended in the future is \$300.00.

3. EFFECTIVE DATE These charges and fees shall become effective August 1, 2005.

4. OTHER CHARGES The fee set forth in Section 1 is not in lieu of any U.L.I.D. assessments, permit fees or any other fees or charges of the District heretofore or hereafter adopted.
