RESOLUTION NO. 63

A RESOLUTION approving and confirming the assessments and assessment roll for Local Improvement District No. 6 in Silver Lake Water District, Snohomish County, Washington, in the sum of \$ 25,526.89, for the improvement of the property described in Section 1 of this Resolution, by the construction and installation of a distribution system of water mains, and doing all necessary work in connection therewith necessary to conduct water from the Silver Lake Water District General Supply System to the property within the boundaries described in Section 1, in accordance with Resolution No. 53 of said Water District, passed on the 11th day of July, 1955, levying an assessment on account thereof against the several tracts, lots and parcels of land as shown on said roll, and no person appearing to object to said assessment roll and no written protests having been filed, NOW, THEREFORE:

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER DISTRICT, SNOHOMISH COUNTY, WASHINGTON:

Section 1: That the assessments and the assessment roll, as the same now stands, of Local Improvement District No. 6 for the improvement of the following described property in said Water District, to-wit:

Beginning at a point on the North line of Section 19, Township 28 N.R. 5 E.W.M., 608.164 feet East of the Northwest corner of said section; thence proceeding East along said North line to the North Quarter corner of said section; thence South along the North-South center line to the South line of the North Half of the Southwest Quarter of Section 19; thence West to the Southwest corner of the East half of the Northwest Quarter of the Southwest Quarter Section 19; thence North along the West line of the East half of the West half of the West half, Section 19 to the point of beginning, situate in Snohomish County, Washington.

by the construction of and installation of a distribution system of water mains and doing all necessary work in connection therewith necessary to conduct water from the Silver Lake Water District General Supply System to the property above described, in accordance with Resolution No. 53, passed on the 11th day of July, 1955, be and the same is hereby in all things approved and confirmed.

Section 2: That each of the lots, tracts and parcels of land or other property, shown on said roll is hereby declared to be specially benefited by said improvement in at least the amount charged against the same, and that the assessment appearing against the same is in proportion to the several assessments appearing upon said roll, and there is hereby levied an assessment against each lot, tract and parcel of land, or other property appearing upon said roll, the amount finally charged against the same.
