RESOLUTION NO. 715

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER AND SEWER DISTRICT OF SNOHOMISH COUNTY, WASHINGTON, APPROVING THE TRANSFER OF CERTAIN ASSETS TO ALDERWOOD WATER AND WASTEWATER DISTRICT IN ACCORDANCE WITH THE TERMS AND CONDITIONS OF THE AGREEMENT DATED APRIL 25, 2013, BETWEEN ALDERWOOD AND THE SILVER LAKE WATER AND SEWER DISTRICT CONCERNING WHOLESALE WATER SUPPLY.

WHEREAS, the Silver Lake Water and Sewer District ("Silver Lake" or "District") is a Title 57 RCW water-sewer district providing water and sewer service within its corporate and service area boundaries, including areas within the Cities of Everett, Mill Creek, and Snohomish County; and

WHEREAS, the District is authorized under the law of the State of Washington to supply potable water to its retail customers and to enter into wholesale contracts for the purchase and sale of wholesale water supply; and

WHEREAS, the District entered into an agreement with the Alderwood Water and Wastewater District ("Alderwood") entitled "Wholesale Water Supply Agreement between Alderwood Water and Wastewater District and Silver Lake Water and Sewer District ("Agreement" concerning the purchase and sale of wholesale water supply; and

WHEREAS, Silver Lake installed Master Meter No. 10 in accordance with Section VII of the Agreement as a public works project; and

WHEREAS, the Agreement provides that all master meters, including vaults and appurtenances, used to convey wholesale water supply from Alderwood to the District will be owned, maintained, repaired, replaced, and upgraded by Alderwood; and

WHEREAS, Silver Lake has granted final acceptance of the Master Meter No. 10 Project by motion at the Board of Commissioners Meeting dated May 28, 2015; and

WHEREAS, in accordance with the terms and conditions of the Agreement the cost of the new Master Meter No. 10 CIP, including appurtenances and installation, has been paid for by Silver Lake, and Silver Lake now desires to transfer such personal property as required by the Agreement with the attached Cost of the System Form and Bill of Sale Form ("Exhibit A") describing the assets being conveyed to Alderwood; and

WHEREAS, Chapter 39.33 RCW, the Intergovernmental Disposition of Property Act and the Agreement, authorize the District to transfer the personal property to Alderwood for the consideration referenced in the Agreement; now, therefore,

BE IT RESOLVED by the Board of Commissioners of Silver Lake Water and Sewer District, Snohomish County, Washington, as follows:

- 1. Silver Lake has completed the MM 10 Capital Improvement Project. The total cost of the Project is \$802,446.00. In accordance with the Agreement Silver Lake is to transfer certain assets obtained by this Capital Improvement Project to Alderwood.
- 2. The transfer of certain assets as stated in the Agreement and described in **Exhibit** "A" attached hereto, and incorporated herein by this reference describing the assets being conveyed to Alderwood, is hereby approved subject to the terms and conditions of the Agreement.
- 3. In accordance with the terms and conditions of the Agreement, the transfer of said assets shall be effective upon Alderwood's acceptance of the Bill of Sale for the identified assets.
- 4. District Staff and the Consulting Engineer are authorized and directed to take all actions necessary to transfer certain assets described in Exhibit A as stated in the Agreement.

The undersigned further warrants that in the event any lawsuit is filed as a result of, or involving, this project the undersigned will undertake to defend the lawsuit and will accept responsibility for all costs of litigation, including costs on appeal, and will hold Alderwood harmless on any judgment rendered against Alderwood.

The undersigned further warrants that all laws, ordinances and regulations respecting construction of this project have been complied with, and that the property is in proper working condition, order and repair and fit for purposes intended; i.e., for use as a Master Meter and has been constructed in accordance with the conditions and standards of the Alderwood Water & Wastewater District, and the Silver Lake Water and Sewer District.
