WHEREAS, the Silver Lake Water and Sewer District and the Alderwood Water & Wastewater District are political subdivisions and special purpose water-sewer districts pursuant to Title 57 Revised Code of Washington (RCW) under the laws of the State of Washington; and

WHEREAS, RCW 39.34.030 authorizes two or more public agencies to enter into agreements for joint or cooperative action pursuant to the provisions of Chapter 39.34 RCW; and

WHEREAS, RCW 57.08.005 authorizes water-sewer districts to purchase equipment, supplies, and materials in accordance with the procedures set forth therein; and

WHEREAS, the Silver Lake Water and Sewer District and the Alderwood Water & Wastewater District desire to utilize each other's bid, proposal, and contract procurement agreements, when it is in their mutual interest.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Silver Lake Water and Sewer District, Snohomish County, Washington as follows:

- 1. The Commissioners hereby authorize the Intergovernmental Cooperative Purchasing Agreement with the Alderwood Water & Wastewater District in the form attached hereto.
- 2. The Commissioners hereby authorize and direct Curt Brees, General Manager of the District, with full authority to sign the Intergovernmental Cooperative Purchasing Agreement with the Alderwood Water & Wastewater District on behalf of the District.
