RESOLUTION NO. 758

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER AND SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, ESTABLISHING UNIFORM SEWER SPECIAL CONNECTION CHARGES FOR THE SECTOR 7 LIFT STATION PROJECT

WHEREAS, Silver Lake Water and Sewer District ("District") owns and operates a public water system and a wastewater collection system pursuant to Title 57 of the Revised Code of Washington located in the Silver Lake area in Snohomish County, Washington; and

WHEREAS, a developer ("Developer") previously installed a sewer lift station referred to as the Sector 7 Lift Station ("Lift Station") to make District sewer service available to the Developer's property, and the ownership of the Lift Station was conveyed to the District and is a part of the District's wastewater collection and transmission system; and

WHEREAS, pursuant to RCW 57.22.050, the District paid a portion of the cost of the construction and installation of the Lift Station to provide additional wastewater capacity in the Lift Station to serve properties not being developed by the Developer. Gray & Osborne, the District's Consulting Engineer ("Consulting Engineer"), has certified to the District that the District paid the amount of \$1,892,976.10, Exhibit "A", for the cost of the construction and installation of the Lift Station and the additional capacity in the Lift Station; and the Consulting Engineer has reported the additional capacity in the Lift Station is available to serve 2,852 Single Family Residential Units, or Equivalent Residential Units ("ERUs"), as summarized in the attached Exhibit "C"; and

WHEREAS, RCW 57.08.005 (11) authorizes the District to charge property owners seeking to connect to the District's sewer system, as a condition to granting the right to so connect, such reasonable connection charges as the District's Board of Commissioners shall determine to be proper, in order that such property owners shall bear their equitable share of the cost of such system; and

WHEREAS, the Consulting Engineer and District staff have recommended the District adopt a Special Sewer Connection Charge for the Lift Station improvements for the owners of real property seeking connection to the portion of the District's sewer system which will use the capacity paid for by the District in the Lift Station; and the Consulting Engineer has recommended the District (a) establish a Special Sewer Connection Charge applicable to properties that connect to or use the Lift Station as depicted on Exhibit "B" attached hereto and incorporated herein by this reference, based on the location of such properties and the sewer system improvements necessary to make permanent public sewer service available to and for the connection of such real property to the District's sewer system, and (b) include in such Special Sewer Connection Charge an interest charge applied from the date of completion of construction

of the Sector 7 Lift Station until connection, or for a period not exceeding ten years, whichever is shorter, at a rate of 2.77%, commensurate to the rate of interest applicable to the District at the time of installation of the improvements to which the property owner is seeking to connect to; and

WHEREAS, the District scheduled a Public Hearing on the proposed adoption of such special connection charges pursuant to the Public Notice published in the Everett Herald; and the District held such Public Hearing on April 26, 2018, and having received the oral and written report and recommendation of the Consulting Engineer, District staff and public comment thereon; now, therefore,

BE IT RESOLVED by the Board of Commissioners of the Silver Lake Water and Sewer District of Snohomish County, Washington, as follows:

1. **Definitions**: The terms set forth herein are defined in Resolution No. 674, a resolution establishing General Facility Charges for new water and sewer connections and such terms may be subsequently be modified and amended.

2. <u>Special Connection Charge</u>. A Special Sewer Connection Charge of Six Hundred Sixty-three Dollars and 75/100 (\$663.75) per ERU to be connected to the District's sewer system, is hereby adopted and shall be assessed against owners of such real property that connect to or use the Sector 7 Lift Station as depicted on **Exhibit "B"** attached hereto. The Sector 7 Special Sewer Connection Charge shall be paid to the District at the time a Developer Extension Agreement is accepted by the District; or, when a Developer Extension Agreement is not required, at the time a customer makes application for a new or upsized sewer connection.

3. **Interest**. The Special Sewer Connection Charge referenced in Section 2 above, shall be adjusted as necessary at the time such charges are payable to the District, to include an interest charge of two point seven-seven percent (2.77%) per annum applied from the date of completion of construction of the Lift Station improvements until the connection, or for a period not to exceed ten (10) years. The Special Sewer Connection Charge including interest by year of connection is shown in the attached **Exhibit "D**".

- 1. Effective April 27, 2018 to December 31, 2018, the total Sector 7 Special Sewer Connection Fee shall be \$810.85;
- 2. Effective January 1, 2019 to December 31, 2019, the total Sector 7 Special Sewer Connection Fee shall be \$829.20;
- 3. Effective January 1, 2020 and beyond, the total Sector 7 Special Sewer Connection Fee shall be \$847.60;
- 4. **Recorded Notice**. Notice of the adoption of the Special Sewer Connection Charge referenced in Section 2 above, shall be recorded with the Snohomish County Auditor's Office together with the attached **Exhibit "B"**, describing the real property to which such special connection charges apply.

- 5. <u>Effective Date</u>. This Resolution shall be effective the date of its adoption set forth below.
- 6. Other District and Agency Fees and Charges. Any charges owing as established by this Resolution by any party seeking to connect to the District's sewer system, shall be in addition to any and all other District sewer fees and charges, connection or otherwise, as established by District resolution, policy or procedure, and such sewer fees and charges of other governmental agencies such as Snohomish County.




Exhibit "B" – Sector 7 Special Sewer Connection Fee Area Map
