A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE SILVER LAKE WATER AND SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, DECLARING CERTAIN DISTRICT PERSONAL PROPERTY TO BE SURPLUS AND DETAILING TERMS OF SALE OR DISPOSAL OF SUCH PROPERTY

WHEREAS, RCW 57.08.015 requires the District's Board of Commissioners to declare property as surplus before selling the property by private or public sale; and

WHEREAS, District staff has identified technology products no longer needed by the District, as outlined in Attachment "A", with an estimated value of less than \$2,500.00 and will be sold at private sale; and

WHEREAS, District staff has identified other property and/or technology products no longer needed by the District, as outlined in Attachment "B", where the estimated value is insufficient to provide economic benefit to the District or in the case of technology products, the potential for release of personnel identifying information of District staff and District customers, as well as potential release of District security codes and passwords that present a security risk to the District and others greater than any economic benefit to the District upon any sale of these items. These items will have any memory storage removed and destroyed and then will be recycled or disposed in the appropriate manner.

NOW, THEREFORE, BE IT RESOLVED:

- 1. The Board of Commissioners now determines that each piece of property listed in Attachments "A" and "B" of the District is not and will not be needed for District purposes or has become unsuitable for public use.
- 2. The Board of Commissioners directs District staff to sell at private auction, the technology products listed in Attachment "A" in accordance with a process determined by the District's General Manager.
- 3. The Board of Commissioners directs District staff to destroy and dispose of the property listed in Attachment "B". For technology products that have a memory storage device

or hard disk drive, such devices are to be removed and physically destroyed prior to disposal.

4. In the event District staff are unable to sell any of the Property listed in Attachment "A", District staff are authorized and directed to dispose of such Property at the least cost to the District.
