RESOLUTION NO. 780**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER AND SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, ADOPTING THE SILVER LAKE WATER AND SEWER DISTRICT CODE.**

**WHEREAS**, Silver Lake Water and Sewer District (District) is a Washington water-sewer district formed under the authority of Title 57 Revised Code of Washington (RCW) to provide water supply and sewer service to its customers; and

**WHEREAS**, pursuant to RCW 57.12.010, the District Board of Commissioners has periodically adopted resolutions which include formal policies and procedures regarding the governance of the District, some of which it now desires to compile into a code that is accessible to its customers and the public; now, therefore,

**BE IT RESOLVED** by the Board of Commissioners of the Silver Lake Water and Sewer District of Snohomish County, Washington, as follows:

**Section 1 - Adoption.**

The Silver Lake Water and Sewer District Code, as compiled from the District's resolutions and edited and published by Code Publishing Company of Seattle, Washington, is hereby adopted as the official Code of Silver Lake Water and Sewer District.

**Section 2 - Title – Citation – Reference.**

The code shall be known as the "Silver Lake Water and Sewer District Code" and it is sufficient to refer to said code as the "District Code" in any proceeding at law or equity. It is sufficient to designate any resolution adding to, amending, correcting or repealing all or any part or portion thereof as an addition to, amendment to, correction or repeal of the Silver Lake Water and Sewer District Code. Further reference may be had to the titles, chapters, sections and subsections of the Silver Lake Water and Sewer District Code and such references shall apply to that numbered title, chapter, section or subsection as it appears in the District Code.

**Section 3 - Title, Chapter, and Section Headings.**

Title, chapter, and section headings contained in the District Code shall not be deemed to govern, limit, modify or in any manner affect the scope, meaning or intent of the provisions of any title, chapter or section of the District Code.

**Section 4 - Interpretation.**

The following rules of interpretation and application shall apply to the District Code:

- (1) Wherever reference is made to gender, gender includes the masculine, feminine, and neutral genders.
- (2) The singular shall include the plural and the plural shall include the singular.
- (3) Present tense shall include the past and the future tenses and vice versa unless stated otherwise or manifestly inapplicable.
- (4) Whenever any act or omission is made unlawful by the District Code, it shall include causing, allowing, permitting, aiding, abetting, suffering, or concealing the fact of such act or omission.
- (5) Whenever a time within to act is set forth in the District Code, the time shall be computed by excluding the first day and including the last day, unless the last day is a Saturday, Sunday, or a holiday, in which case the last day shall be the next regular business day.

**Section - Reference Applies to all Amendments.**

Whenever a reference is made to the District Code as the “Silver Lake Water and Sewer District Code” or to any portion thereof, or to any resolution of Silver Lake Water and Sewer District, the reference shall apply to all amendments, corrections and additions heretofore, now or hereafter made.

**Section 6 - Reference to Specific Resolutions.**

The provisions of the District Code shall not in any manner affect matters of record which refer to, or are otherwise connected with, resolutions which are therein specifically designated by number or otherwise and which are included within the District Code, but such reference shall be construed to apply to the corresponding resolution provisions contained within the District Code.

**Section 7 - Effect of District Code on Resolutions – Future Resolutions.**

The adoption and provisions of the District Code shall not be construed as affecting the validity of any resolution of Silver Lake Water and Sewer District or any provision thereof and the language of a resolution shall prevail in the event of any conflict. Not all District resolutions are adopted and codified in this code, and the District General Manager shall determine which resolution or provision(s) thereof will be added to the District Code and shall update the District Code not less frequently than annually. The determination not to include any resolution or provision(s) thereof in the District Code shall not affect the validity or effect of said resolution or provision.

**Section 8 - Effect of District Code on Past Actions and Obligations.**

Neither the adoption of the District Code nor the repeal or amendment hereby of any District resolution or part or portion thereof shall be construed as a waiver of any interest, right,

obligation, license, or fee as of the effective Date of the District Code as set forth below, nor be construed as affecting any of the provisions of such resolution and all rights and obligations thereunder appertaining shall continue in full force and effect.


**Section 9 - Severability.**

If any section, subsection, sentence, clause or phrase of this code is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of the District Code. The District Board of Commissioners declares that it would have approved and enacted the District Code, and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases had been declared invalid or unconstitutional, and if for any reason the District Code should be declared invalid or unconstitutional, then the original resolution or resolutions shall be in full force and effect.


**Section 10 - Effective Date.**

This resolution is effective the date set forth below.


