WHEREAS, District staff has identified miscellaneous equipment that is no longer needed by the District, as outlined in Attachment "A", with an estimated value of less than \$2,500.00 and will be sold at public auction or private sale; and

NOW, THEREFORE, BE IT RESOLVED:

- 1. The Board of Commissioners now determines that each piece of property listed in Attachments "A" is not and will not be needed for District purposes or has become unsuitable for public use.
- 2. The Board of Commissioners directs District staff to sell at public auction or private sale, the miscellaneous equipment listed in Attachment "A" in accordance with a process determined by the District's General Manager.
- 3. In the event District staff are unable to sell any of the Property listed in Attachment "A", District staff are authorized and directed to dispose of such Property at the least cost to the District.
