RESOLUTION NO. 809**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE SILVER LAKE WATER AND SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, REPEALING RESOLUTION NO. 684 DATED JUNE 26th, 2012, REGARDING THE COLLECTION OF LATECOMER/REIMBURSEMENT CHARGES ON EXPIRED REIMBURSEMENT CONTRACTS.

WHEREAS, On June 26th, 2012 the Board of Commissioners of the Silver Lake Water and Sewer District (District) adopted Resolution No. 684, codified as Chapter 9.10.150 of the District Code; and

WHEREAS, Resolution No. 684 ratified and confirmed a District policy regarding the collection of Latecomer/Reimbursement Charges on Expired Reimbursement Contracts; and

WHEREAS, RCW 57.08.005(11) authorizes the District to charge property owners seeking connection to the District's water and sewer systems, as a condition to granting the right to so connect, in addition to the cost of the connection, such reasonable connection charges as the District's Board of Commissioners shall determine to be proper in order that such property owners shall bear their equitable share of the cost of the systems; and

WHEREAS, the District's current policy requires that property owners who connect to, or use water or sewer extension facilities subject to a reimbursement contract which has expired, pay such reimbursement charge to the District in addition to all other applicable District rates and connection charges, because such property owners did not contribute to the original cost of such facilities and the District incurred the expense to own, operate, maintain, and replace such facilities; and

WHEREAS, it is within the statutory discretion of the Board of Commissioners to establish rates and connection charges and the District's Board of Commissioners now desire to establish a revised policy concerning collection of Reimbursement Charges on Expired Reimbursement Contracts providing that such charges will no longer be collected once the Reimbursement Contracts have expired; now, therefore,

BE IT RESOLVED by the Board of Commissioners of the Silver Lake Water and Sewer District, Snohomish County, Washington as follows:

Section 1: Resolution No. 684, dated June 26th, 2012, codified as Chapter 9.10.150 of the Silver Lake Water and Sewer District Code, is hereby repealed and nullified.


