## A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE SILVER LAKE WATER AND SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, DECLARING CERTAIN DISTRICT PERSONAL PROPERTY TO BE SURPLUS AND DETAILING TERMS OF SALE OR DISPOSAL OF SUCH PROPERTY

WHEREAS, RCW 57.08.015 requires the District's Board of Commissioners to declare property as surplus before selling the property by private or public sale; and

WHEREAS, District staff has identified that a 2014 Ford Escape SUV, Vehicle No. 59, that is no longer needed by the District, with an estimated value of more than \$2,500.00, will be sold at a public auction; and

WHEREAS, District staff has identified miscellaneous equipment that is no longer needed by the District, as outlined in Attachment "A", with an estimated value of less than \$2,500.00 and will be sold through private sale; and

## NOW, THEREFORE, BE IT RESOLVED:

- 1. The Board of Commissioners now determines that Vehicle No. 59, 2014 Ford Escape SUV and the miscellaneous equipment outlined in Attachment "A", is not and will not be needed for District purposes or has become unsuitable for public use.
- 2. The Board of Commissioners directs District staff to sell at public auction, Vehicle No. 59, the 2014 Ford Escape.
- 3. The Board of Commissioners directs District staff to sell through private sale, the miscellaneous equipment listed in Attachment "A" in accordance with a process determined by the District's General Manager.
- 4. In the event District staff are unable to sell any of the Property listed in Attachment "A", District staff are authorized and directed to dispose of such Property at the least cost to the District.
