RESOLUTION NO. 828**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE SILVER LAKE WATER AND SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, AWARDING THE 2022 VALVE AND MANHOLE ADJUSTMENT PROJECT TO QUILCEDA EXCAVATION, INC.**

**WHEREAS**, RCW 57.08.050 requires that the District's Commissioners let contracts for Public Work, in excess of \$50,000, go through a competitive bidding process; and

**WHEREAS**, the District received bids for the 2022 Valve and Manhole Adjustment Project on April 19, 2022, and the apparent low bid was submitted by Quilceda Excavation, Inc., in the amount of \$297,020.66; and

**WHEREAS**, District staff have completed the review of Quilceda Excavation, Inc. qualifications, and Quilceda Excavation, Inc. is currently a Washington State registered and licensed contractor and appears to have the relevant qualifications and experience to successfully perform the work that the project will require; and


**WHEREAS**, the District Engineer recommends that the District award the 2022 Valve and Manhole Adjustment Project to Quilceda Excavation, Inc. as the lowest responsive and responsible bidder.

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1.** The 2022 Valve and Manhole Adjustment Project is hereby awarded to Quilceda Excavation, Inc. as the lowest responsive, responsible bidder, in the amount of \$297,020.66, including sales tax; and
- 2.** The District's General Manager is hereby authorized to execute the Contract on behalf of the District as appropriate; and
- 3.** The District's General Manager is hereby authorized to issue a Notice to Proceed to Quilceda Excavation, Inc. as appropriate.


