RESOLUTION NO. 838

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER & SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, WAIVING COMPETITIVE BIDDING REQUIREMENTS DUE TO MARKET CONDITIONS AND AUTHORIZING AND DIRECTING STAFF TO PURCHASE A FORD F-350 TRUCK FOR AN AMOUNT NOT TO EXCEED \$57,000 FROM BELLINGHAM FORD LINCOLN.

WHEREAS, Silver Lake Water & Sewer District ("District") is a special purpose water-sewer municipal corporation authorized and existing under the laws of the State of Washington, Title 57 RCW, and owns and operates a water and sewer system pursuant to that authority within its service area; and

WHEREAS, the District Board of Commissioners previously authorized and directed District staff to purchase a 2022 Ford F-350 Truck as part of the District's Equipment Replacement Schedule, to assist the District in maintaining its system, and to provide safe and cost-effective water and sewer services to its customers; and

WHEREAS, District staff in late 2021 ordered a 2022 Ford F-350 Truck and other vehicles from the vendor awarded the State Contract for Ford vehicles that complies with all statutory bidding requirements; and

WHEREAS, the District is authorized to purchase vehicles using the State Contract according to the terms of an Interlocal Agreement with the Department of Enterprise Services; and

WHEREAS, in the fall of 2022 District staff were informed by the State bid vendor that the manufacturer had canceled four of the five vehicles, including the Ford F-350 Truck, that the District had on order for delivery in 2022, due to supply chain shortages; and

WHEREAS, District staff reordered the vehicles that were not delivered in 2022, according to the terms of the State Contract at increased cost for the 2023 model year; and

WHEREAS, District staff has informed the Board that due to the typical delays associated with ordering a truck using the State Contract, it is unlikely the District would be able to obtain the Ford F-350 Truck within an acceptable amount of time and there is no guarantee the order will not again be canceled; and

WHEREAS, current economic uncertainty has led some buyers of commercial trucks to forgo delivery of vehicles they had on order, one such vehicle is nearly identical to the Ford F-350 Truck the District ordered; and

WHEREAS, District staff has informed the Board that they believe the District's needs can be met by purchasing a new 2022 Ford F-350 Truck from Bellingham Ford Lincoln existing stock; and

WHEREAS, the existing stock vehicle is a 2022 model, and it is available at a lower cost than the District's pending order for a 2023 vehicle, according to the terms of the State Contract; and

WHEREAS, District staff has informed the Board that due to current vehicle market conditions, it is impossible to follow competitive bidding requirements and still acquire a new truck within an acceptable amount of time that meets the District requirements; and

WHEREAS, the District has the authority to waive competitive bidding requirements set forth in RCW 57.08.050 pursuant to RCW 39.04.280; now therefore,

BE IT RESOLVED by the Board of Commissioners of Silver Lake Water & Sewer District of Snohomish County, Washington, as follows:

- 1. The Recitals set forth above are adopted as if set forth in full herein.
- 2. The competitive bidding requirements set forth in RCW 57.08.050 are hereby waived, due to market conditions as allowed for in RCW 39.04.280 (1)(b) in relation to the purchase of a new 2022 Ford F-350 Truck, and District staff are authorized and directed to timely purchase the 2022 Ford F-350 Truck that will serve the District's needs in an amount not to exceed \$57,000.
