**RESOLUTION NO. 852**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER AND SEWER DISTRICT, SNOHOMISH COUNTY, WASHINGTON, AUTHORIZING THE PURCHASE OF A BOBCAT COMPACT TRACK LOADER, ATTACHMENTS, AND TRAILER, UTILIZING THE SOURCEWELL CONTRACT FOR COOPERATIVE PURCHASING TO MEET THE DISTRICT'S COMPETITIVE BIDDING REQUIREMENTS.**

**WHEREAS**, Silver Lake Water and Sewer District ("District") needs to ensure the District's water and sewer pipe networks are operational at all times, to provide uninterrupted service to customers; and

**WHEREAS**, easements where the pipelines are located require vegetation maintenance to provide access for inspection, maintenance, and emergency work; and

**WHEREAS**, the District maintains 11 miles of water and sewer easements that are maintained for access to infrastructure; and

**WHEREAS**, the District currently operates a Trackhoe equipped with a brush cutting head to perform vegetation maintenance. The Trackhoe unit is very effective to clear dense vegetation or cut along slopes, but is not time efficient in all situations; and

**WHEREAS**, a smaller, multi-purpose tracked skid steer unit will provide greater efficiency to mow open easement areas and many other tasks specific to the District's needs; and

**WHEREAS**, District staff have researched tracked skid steer machines available on purchasing contracts and have identified the Bobcat Compact Track Loader will be best suited to the needs of the District; and

**WHEREAS**, Sourcewell Cooperative has issued a Purchasing Contract (040319-CEC) which includes the type of Compact Loader and Trailer that are required by the District; and

**WHEREAS**, RCW 39.34.030 permits the District to enter into agreements with other public agencies for joint or cooperative action; and

**WHEREAS**, the District is a member of the Sourcewell Interlocal Contract for Cooperative Purchasing, which allows the District to use the contract with Bobcat of Marysville; and

**WHEREAS**, the competitive bidding requirements, applicable to the District, set forth in RCW 57.08.050, have been met; now, therefore,

**BE IT RESOLVED**, by the Board of Commissioners of Silver Lake Water and Sewer District, Snohomish County, Washington, as follows:

1. The recitals set forth above are incorporated herein by this reference.
2. The competitive bidding requirements applicable to the District, as set forth in RCW 57.08.050, have been met.
3. Therefore, the purchase of a Bobcat Compact Track Loader, attachment accessories, and Towmaster Trailer, utilizing the Sourcewell Contract (040319-CEC), totaling \$101,707.03 plus applicable tax, is hereby authorized.
