RESOLUTION NO. 96

A RESOLUTION approving and confirming the assessments and assessment roll for Local Improvement District No. 10 in Silver Lake Water District, Snohomish County, Washington, in the sum of \$14,129.90 for the improvement of the property described in Section 1 of this Resolution, by the construction and installation of a distribution system of water mains, and doing all necessary work in connection therewith necessary to conduct water from the Silver Lake Water District General Supply System to the property within the boundaries described in Section 1, in accordance with Resolution No. 88 of said Water District, passed on the 10th day of November, 1958, levying an assessment on account thereof against the several tracts, lots and parcels of land as shown on said roll, and no person appearing to object to said assessment roll and no written protests having been filed,

NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF SILVER LAKE WATER DISTRICT, SNOHOMISH COUNTY, WASHINGTON:

Section 1: That the assessments and the assessment roll, as the same now stands, of Local Improvement District No. 10 for the improvement of the following described property in said Water District, to-wit:

Beginning at the northeast corner of Section 31, Township 28 North, Range 5 East; thence West to the NW corner of the NE 1/4 of the NE 1/4 of said Section; thence South to the SE corner of the N 1/2 of the N 1/2 of the NW 1/4 of the NE 1/4 of said Section 31; thence along the south line of said N 1/2 of the N 1/2 to the west line of NE 1/4 of said Section 31; thence south along said line to the center of Section 31; thence east along the south line of the NE 1/4 of said Section 31 to the SE corner of the SW 1/4 of the NE 1/4; thence north along the east line of the SW 1/4 of the NE 1/4 to the NE corner thereof; and continuing north 170.7 feet more or less along the east line of the NW 1/4 of the NE 1/4 to a point 330 feet southeasterly from the centerline of State Highway No. 2-A, measured at right angles from said centerline; thence along a line bearing N 38° 11' East which is parallel and 330 feet distant from the centerline of said Highway a distance of 421.8 feet more or less; thence on a curve to the right having a radius of 625.4 feet to the intersection of the south line of the N 1/2 of the NE 1/4 of the NE 1/4 of said Section 31; thence east along said south line to the east line of Section 31; thence north along

said line to the NE corner of Section 31, the point of beginning, situate in Snohomish County, State of Washington.

by the construction of and installation of a distribution system of water mains and doing all necessary work in connection therewith necessary to conduct water from the Silver Lake Water District General Supply System to the property above described, in accordance with Resolution 88, passed on the 10th day of November, 1958, be and the same is hereby in all things approved and confirmed.

Section 2: That each of the lots, tracts and parcels of land or other property shown on said roll is hereby declared to be specially benefited by said improvement in at least the amount charged against the same, and that the assessment appearing against the same is in proportion to the several assessments appearing upon said roll, and there is hereby levied an assessment against each lot, tract and parcel of land, or other property appearing upon said roll, the amount finally charged against the same.
