Minutes of a meeting of SILVER LAKE WATER DISTRICT held on Monday, October 24th, 1955 at 8:00 o'clock, P.M. at the home of Leo Nelson at Silver Lake, meeting being called to order at 8:00 o'clock P.M. by Jake Michel, Chairman.

Those present consisted of Three Commissioners, Engineer, the Attorney, and several bidders and representatives of bidders.

The Minutes of the previous meeting were read and approved as read.

The first order of business was the opening of bids for L. I. D. No. 7. A number of bids were received, the successful bidder being F. M. TAYLOR on their low bid of Twenty-Five Thousand Four Hundred Fifty Dollars and two cents (\$25,450.02). This is the corrected bid, as a mistake was made of a few dollars in computation of the bid, the bid on the bidder's sheet being Twenty-Five Thousand Four Hundred Thirty-Eight Dollars and eighty-six cents (\$25,438.86). A copy of the bid is as follows:
